DESCRIPTION OF SJI FUNDS

Donations to the St. Joseph's Institution Endowment Fund and the St Joseph's Institution Scholarships Fund receive a 2.5 times tax deduction.

ST JOSEPH'S INSTITUTION ENDOWMENT FUND

The St Joseph's Institution Endowment Fund is an investment fund in which the income generated from the invested capital is used to fund the advancement of education. The principal sum is not used.

The investment income derived from the St Joseph's Institution Endowment Fund may be applied as follows :

1. Deficit financing of such operational expenses of the School as are approved by the SJI Board of Governors and cannot be met out of Govt Grant, fees, donations or other income of the School,
2. Grants for staff and pupils to enable them to go for such further studies, training, exchange programmes, and educational tours as are approved by the SJI Board of Governors.
3. Financing of such pastoral care programmes as are approved by the SJI Board of Governors.
4. Initial funding for fund-raising projects for the School and/or the St Joseph's Institution Endowment Fund.
5. Such administrative and other expenses as are necessary for the efficient operation of this Fund subject to the approval by the SJI Board of Governors.
6. And generally, such projects/schemes for the advancement of the School's education objectives as are approved by the SJI Board of Governors.
7. Student assistance schemes, scholarships, bursaries and/or other awards for the educational needs of the students.
8. Financing of operating expenses for the educational needs of the School as are approved by the SJI Board of Governors.

ST JOSEPH'S INSTITUTION SCHOLARSHIPS FUND

The St Joseph's Institution Scholarships Fund is used to fund scholarships and awards for the academically outstanding students. It may also be used to provide school pocket money for needy students and/or other educational purpose(s) approved by MOE.

ST JOSEPH'S INSTITUTION (WONG KOK SIEW – SVDP FUND)

The Wong Kok Siew–SVDP Fund supports needy students in terms of fees, costs, and/or expenses for the School's educational programmes and/or other educational purpose(s) approved by MOE. It either supplements financial assistance schemes provided by MOE, where necessary, or provides financial assistance to needy students who are not eligible for the MOE Independent School Bursary (MOE ISB) scheme, for example, on a short term basis arising from unanticipated family circumstances. Singaporean students receive priority for financial support under this fund.
